2. The nomination papers of the contesting candidates were examined on 11.08.2026 and 12.08.2026 at the office of the Deputy Commissioner, G-11/4, ICT, Islamabad, under the supervision of the Assistant Commissioner (I. Area)/Election Commissioner, Multi-Professional Cooperative Housing Society, Islamabad, in the presence of the members of the Election Commission. The scrutiny proceedings were conducted in light of the Cooperative Societies Act, 1925, and relevant provisions of law. The candidates present, along with their respective proposers and seconders, duly signed the attendance sheet.

3. At the time of scrutiny of the nomination papers, all the candidates present, except two, were heard in person. They were also provided an opportunity to raise any objections; however, none of the candidates submitted any objection. During the scrutiny proceedings, the dues status of all the candidates was also examined on the basis of the record produced by the Society.

4. Moreover, two candidates, namely Mr. Nadeem Afzal, contesting for the post of Executive Member of the Managing Committee, and Mr. Muhammad Iqbal, contesting for the post of Executive Member of the Managing Committee, remained absent from the scrutiny proceedings. The said candidates were subsequently contacted and requested to appear before the election commission and participate in the scrutiny process; however, both candidates refused to appear and categorically informed that they were no longer willing to contest the election. Accordingly, in view of their refusal to participate in the scrutiny proceedings and their express unwillingness to contest the election, the candidature of Mr. Nadeem Afzal and Mr. Muhammad Iqbal is hereby declared disqualified, and they shall not be entitled to contest the forthcoming election for the post of Executive Member of the Managing Committee. Accordingly, the list of candidates is as under:

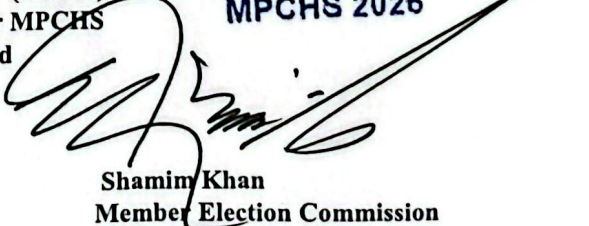
